3. Treasurer's report

CB reported that the Bracknell coach had made a profit of over £200 which meant that the balance for the season is now in the black.

She had received a complaint from a supporter for the decision not to advertise a coach for Chelmsford.

The Slough coach will run if there are sufficient bookings and it was agreed to advertise coaches for the trips in March to Dover, Worthing and Welling.
